

## **EOS FITNESS GIVEAWAY**

### **OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.**

#### **VOID WHERE PROHIBITED**

#### **ELIGIBILITY:**

1. The giveaway ("Giveaway") is open only to all existing members of EOS Fitness in good standing who are 18 years of age or older.
